ICHOM DEVELOPS THE STANDARD SETS COLLABORATIVELY, BRINGING TOGETHER LEADING PHYSICIANS, REGISTRIES AND PATIENT REPRESENTATIVES FROM ALL OVER THE GLOBE, ICHOM THEN DRIVES THE ADOPTION OF THESE STANDARDS TO ENABLE HEALTH CARE PROVIDERS GLOBALLY TO COMPARE, LEARN AND IMPROVE. IN NOVEMBER 2013, ICHOM LAUNCHED ITS FIRST FOUR STANDARD SETS FOR CATARACTS, CORONARY ARTERY DISEASE, LOCALIZED PROSTATE CANCER, AND LOW BACK PAIN.
